- 3.1 (3.1) Grass cutting contract to consider tenders and additional information Quotations will be brought to the meeting.
- 3.3 (3.5) East West Rail non-statutory consultation to note response made The following response was submitted:

"Toft Parish Council met on 6th January 2025 and unanimously agreed this response to the EWR consultation.

The PC does not support the proposed railway routing as it will have a significant negative impact on the village and it's surrounds during it's operation and particularly during it's construction when enormous areas will be taken over and considerable disruption is to be expected.

The PC again asks that the northern route be fully considered as it still seems to be the best option as it will serve the many thousand of new occupants planned for the area. The PC supports the proposal that an independent review of the project is carried out before progressing and that a business case is published as the PC does not believe a good case for the expense has been made.

If the proposals do go ahead the PC would like to see a cycleway between Hardwick Road and Comberton Road so that pupils and Comberton Village College, living in Hardwick, can safely cycle to school."

4. Correspondence

4.1 <u>CCC proposal to widen and improve the cycle way between Toft and Comberton</u>

"As project manager for the Comberton to Toft shared use path project, I write to you to provide to you the attached CAD plans & to ask for your views on the proposals.

The shared use path between the two villages is aimed to widen the current path to provide infrastructure to allow residents of the two villages & students of Comberton Village College to travel actively if they wish to do so.

Cllr Atkins & Cllr Yeadon, if you are aware of any stakeholders in your views in the area at this stage should be consulted I would be grateful if you could provide details.

I should inform you that currently the project is under the options & feasibility stage & funding is being sought for delivery."

Design plans attached.

4.2 Enquiry about allotment availability including clearance of plot

The following enquiry from a resident of Caldecote has been received:

"I have been down to the allotments in Toft.

I looked at 4a which as you say is very heavily overgrown and is a big ask to cultivate? Will 4a have access to the manual water pump (does it work?) and can the old shed at 2a be accessible to store some of my tools?

Is there any possibility of the land being turned over / cleared - with a small digger or similar by the council ahead of taking up an annual rental ?"

4.3 Finding Fitness Ltd – funding for play area improvements

"Does Toft have a park?

If so, we can add play equipment to your park, without denting any of your existing budgets. We work with you to get funding, and it only takes half an hour of your time.

55 other small Parish Councils have already done this, including nine in Cambridgeshire. Please see the details attached.

I look forward to hearing from you if you think it could be of benefit to your community."

The Clerk has used delegated powers to accept a quote from Suffolk County Council for streetlight energy supply. They have quoted approximately £380 per year and are only able to start quarterly. The Council is expected to save approximately £400 during the 1/1/25 – 31/3/25 quarter over using the current supplier (Opus/Drax).




