- 4.1 <u>CAPALC Introduction of the IT policy requirement as part of the Annual Governance Statement requirements Assertion 10</u>

CAPALC have sent out Webinar slides and a Webinar recording relating to Assertion 10 on the Introduction of the IT policy requirement as part of the Annual Governance Statement next year, together with an example IT policy.

They have stressed that the policy is a guide only and is not to be copied verbatim as it needs to reflect the Council's practices and policies. The example is to help Councils to think about the kind of things that need to be considered for inclusion, and some aspects might need to be added.

CAPALC have also stressed that the contents of the documents must not be shared with any other person, business, organisation, Parish or Town Council.

The Webinar slides, Webinar recording and link as well as the example policy have been circulated to members direct.

4.2 <u>SCDC – Launch of public engagement for Local Government Reorganisation in Cambridgeshire and Peterborough (deadline 20 July)</u>

"I am writing to let you know that today we, along with all the other councils in Cambridgeshire and Peterborough, have <u>launched a public engagement exercise</u> to gather opinions on the future of local government locally. As requested during our first briefing call with Parish and Town Councils on Monday evening, you are also able to view the <u>paper-based version of the form online</u> in case it is helpful for your discussions with your Councillors. We very much encourage Parish and Town Councils to complete the survey before the closing date of Sunday 20 July.

This follows an announcement by the Government in December, setting out plans to move towards a new system of local government, removing the two-tier system of district, city and county councils. Existing unitary councils including Peterborough are also included.

Since then, all seven existing county, district and city councils have been working collaboratively to identify viable options for new single-tier councils across the region.

No decisions have yet been made on what these new arrangements could look like, but the Government has made it clear that it wants these councils to be unitaries (providing all services and covering all current county and district functions).

The <u>survey being launched today</u> asks people what is important in terms of services, what they would like to see delivered by their new unitary authority, and where in Cambridgeshire and Peterborough they visit to socialise, work or access health services. A series of focus groups are also being arranged. This comes after three options for local government reorganisation in Cambridgeshire and Peterborough were shared publicly last week.

Views from the survey will inform the business cases being developed for each of these proposals. Those business cases will then be submitted to the Government in November. The final decisions on which new local government structures are put into place in Cambridgeshire and Peterborough will ultimately be made by national Government.

As well as alerting you to the survey for your own completion, we are also asking if you could share information with your residents and any other interested groups, such as businesses and community organisations. There is both a public survey and one which is tailored for stakeholders and these are available to access via the survey links on our local government reorganisation website page.

We have included some social media messages that you can cut and paste onto your own platforms below, and an image you can use, or if it's easier you can share the social media posts that we will be sharing on this subject.

Any support you can offer in raising awareness of the engagement service would be very much appreciated as we want as many people as possible to share their opinions and help inform the proposals that will be presented to Government later in the year.

The survey is live on each council's website and will close at the end of the day on 20 July 2025.

Hard copies are also available at Council offices and libraries and – as mentioned above – the paper based version can be viewed online.

The Chairman reported on a meeting with representatives of East West Rail.

- Local villages have been split into groups by EWR. Toft is in the group for the area between Croxton and Toft, and the next group covers the area from Comberton to Haslingfield. Cllr Yeadon has written to Comberton Parish Council with a view to sharing information.
- Following the recent consultation, EWR's currently preferred option is for a tunnel under the A428 rather than a covered cutting, and the location of Cambourne Station is being reviewed, but nothing is definite as yet.
- EWR are introducing a community fund whereby communities can apply for funding, with further information expected in September.
- The next phase will be a statutory consultation next year, but delays could occur if the proposals for Universal Studios impact the Tempsford Station. After the statutory consultation it will take a further 12 months to consider and review the responses.
- Further meetings with EWR will take place every three months.

Cllr Darbyshire reported that she had been seeking a meeting with Martin Sebborn about the website, as permission is needed to change the banner image on the home page.

# Residents' comments regarding musical play equipment

#### Resident 1

"My 4 children and I really enjoy the musical equipment at the playground. We think that the sound coming from the musical equipment is quite tuneful! There are few playgrounds locally with similar equipment and the children are very proud of it! It is great for their creative development. Surely the noise of music is better than screaming and shouting. Also, Toft park is surrounded by trees making it quite an enclosed area so surely the noise should not travel as much?"

#### Resident 2

"Following the article in the Toft Village Calendar for June, I am writing to say that we live within earshot of the musical equipment in the Toft Playground, and we love it. It is a beautiful, dreamy sound that wafts on the breeze. Even the drums sound nice. Please ask the council NOT to remove them.

We have to put up with really loud motorbikes driving thru the village. Some are probably deliberately loud. They really are an awful noise problem. There is also the occasional aeroplane that spends too long over the village. There are also leaf-blowers, chain-saws and other power tools, but fortunately the use of these outdoors seems to have declined recently. In comparison to the awful road noise and all these other sources, the musical instruments are wonderful. In fact, there is no comparison. It is really hard to believe that anyone would complain about them.

My granddaughter - aged 3 - loves to play on the musical equipment. Whenever she visits Toft she really enjoys the playground, Many thanks to the council for looking after it. The musical instruments are a key part of that.

I would be very saddened if the village lost the music just because of one complaint. Please do not remove them. The first time we heard them we wondered where on earth the beautiful sounds were coming from. They were an inspired addition to the village. Well done indeed to whoever had the idea!! Utterly brilliant.

And many thanks to the Parish Council for providing and looking after the equipment."

## Resident 3

"I think it's really important that any decision is made with as much feedback from the village as possible. I am strongly in favour of the instruments staying for the following reasons:

- 1. The Parish Council identified that installing the instruments would be of benefit to the village residents.
- 2. They are a resource for the village children and I think they are enjoyed (I can hear the sounds drifting towards School Lane occasionally) 3. It is a pleasant sound 4. The playground has been established for many years and any resident moving into the village near to the play ground should expect a certain level of noise from children playing.

My understanding is that there has been an offer by a resident to pay for the instruments to be moved. It sets a very dangerous president for a single resident to effectively pay to have village infrastructure tweaked to their satisfaction and to the detriment of others.

#### Resident 4

"Concerning the musical equipment in the playground.

I live in [redacted] opposite the playground.

It is such a pleasure to hearing the little children playing on the equipment, but it's not a disturbance and at times hardly hear it.

BUT several times late at night it's a nuisance it's obvious teenagers also with their bikes, AND to be honest don't think it's villages, Please do not punish our little children with taking their pleasure away."

#### Resident 5

"I was saddened and disappointed to read about the complaint against the musical equipment at the park. The upgraded play equipment at the park have been much welcomed and the instruments make such a lovely addition to the park, it was so exciting to see some lovely new items in the park. My toddlers love playing with them, particularly the metal park xylophone that we can both play together and make little tunes with.

Having young children, we go to the park during the day, or on the weekend, so the instruments are not played with during unsociable hours, they are also not played with for particularly long, as most young children find new things to play and do at the park quite quickly, so I am very surprised by the noise complaint made."

## Resident 6

"Thanks for giving us the opportunity to respond to the complaint about the music equipment in the playground. I live opposite but a little way down the road [redacted] and can hear the music when it is used. I find it very charming and really like to hear that children are using it in the playground rather than sitting at home on a screen. Maybe a small sound barrier around it could be erected? I find it very disappointing that people have complained about it, but maybe it is louder for them?"

#### Resident 7

"I would like to register my support for the retention of the new, useful musical equipment in Toft Playground. My grandchildren have used this equipment and enjoy it very much and would like to continue to do so. It is important to have a range of equipment and this less physically demanding play opportunity is good."

#### Resident 8

"I am responding to the notice in the Toft calendar, regarding the noise levels of the musical equipment in the playground.

We live at [redacted] on the opposite side of the road from the playground but pretty close. Before the equipment was installed I did have some misgivings regarding noise. In fact it isn't noisy, intrusive or disruptive, just a gentle sound on the breeze & we like it."

## Resident 9

"I would like to support the residents living close to the village playground, regarding the musical equipment.

As much as it is always lovely to hear children playing and enjoying the lovely facilities in our playground, the introduction of the musical equipment, must be most annoying for those living close by.

I live south of the playground and hear the 'musical' sounds quite often while in the garden, and at times they can be incessant. I have also heard them after dark.

I am not sure what the answer is, they are fun equipment, that are in the wrong place, and to close to homes."

#### Resident 10

"We live opposite the playground at [redacted]. We noticed the sound from the playground when the musical units were first installed, but it very quickly became just part of the village, and to be perfectly honest it is just very nice to hear the playground being used by all ages.

From my perspective, I would be saddened to find the equipment being removed. It is certainly no worse in terms of noise than music from any house or garden party in the area.

Just for information, my son just noticed that the xylophone-style device has been vandalised (unless this has been done deliberately for maintenance?) I've just had a look and it has been ripped out of the ground (complete with the concrete foundation)."

#### Resident 11

"I was saddened to learn that a resident has been complaining about the musical equipment in Toft Playground.

Not only do they wish to deprive the younger members of our village of this innovative piece of equipment but also the grandchildren of the older members of our community when they visit. Why would anyone want to deprive children of any of the items in the Playground? After all it is a PLAYGROUND and children learn through play.

No doubt, after much research, the Paris Council decided to invest on behalf of the village in this piece of equipment. The company which sells this equipment would be aware that in many cases there would be residential housing near by and any noise would need to be of an appropriate level.

My team and I spent four Saturday mornings in February and March clearing the ditch on the south side of Lot Meadow. I was working near the entrance to the Meadow and children did come into the Playground while we were there. The musical equipment was used but it was never intrusive. The attention span of young children is limited and so it was not surprising that it never continued for very long.

As a past member of the PC I am aware that items for the Playground are paid for with S106 monies which can only be used in specifically designated areas or for specifically designated items. I query the legitimacy of the PC to be able to remove this equipment even if they wanted to? I, for one, would feel that it would constitute very poor management of our parish funds. Before buying the equipment the PC did ask for residents opinion on this so they have done their due diligence.

Much as this particular resident does not like the sound of musical notes wafting over her patio, there are a number of nearby residents who actually enjoy hearing the notes drifting by on the wind and knowing that a young child, or even an older resident, is having a 'play'.

There are a number of 'things' that will irritate one person but be perfectly acceptable to another. I do hope that the PC will not be guided by those who shout loudest."

## Resident 12

"I've just heard that the musical instruments at Toft children's playground may be taken away. That would be so sad and disappointing. My grandchildren love them, asking to go to play with them every time they visit.

I didn't think they were particularly loud so am very surprised there have been complaints."

#### Resident 13

"I write in response to the notice in the June Toft Village Calendar about a resident's request for the so-called musical equipment to be removed.

I would fully support this. I do not know who the resident concerned is and have no personal interest in this matter. I live some way away. However, having walked past the playground and heard it being used, I have every sympathy with people living near there. I would not want to have to live close to such a piece of equipment myself and therefore I would support its removal."

#### Resident 14

"Through this email, I wish to support the local resident who has been disturbed by noise emanating from the musical equipment in the children's playground.

The instruments serve little or no creative purpose and are far too loud."
